

**RESOLUTION NO. 3719**

**A RESOLUTION SETTING FEES FOR CITY SERVICES, PERMITS, OR APPLICATION.**

**WHEREAS**, the City of Baker City presently charges for a variety of services, permits, and applications, and

**WHEREAS**, such charges are currently each set by separate resolution or authority of the City Council as need arises and consequently are adopted at different times, and

**WHEREAS**, the City Council is of the collective opinion that such charges should be consolidated into one resolution where both city staff and the citizens of the City of Baker City could determine any of the fees charged by the City,

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Baker City, Oregon that, by virtue of the authorities listed below, the fees set forth below shall be charged for the appropriate service, permit, or application:


